**TERMS & CONDITIONS OF GOLF MEMBERSHIP**

**2023-2024 Membership Privileges and Policies:**

This annual membership is non-equity and carries no equity or ownership rights in Flushing Valley Golf Club. Golf Members are entitled to the privileges listed below:

**Privileges:**

Golf Members shall have full unrestricted golfing privileges (subject to availability) to Flushing Valley Golf Club. Annual Members may be restricted from play during certain events, outings, leagues, etc. We kindly ask that all Golf Members gain permission and/or tee times from the golf professional staff prior to playing.

We will offer an Unlimited Range Pass that carries unrestricted use. Please contact our Pro Shop Staff for the current pricing for this golfing season.

The driving range and practice area will be closed prior to May 1ST and after October 31ST unless changed by Management. To help us provide the very best practice surface, we kindly ask that all annual members follow these restrictions and do not hit from the tee area when the range is closed.

Members shall have charging privileges at Flushing Valley Golf Club. (See billing policy below)

Members are asked to sign each and every purchase and ensure amounts are correct. We cannot guarantee all member discounts will be applied as qualified and we ask that you help by checking your bill and signing off.

#### **Referral Incentive:**

**The Referral Incentive is \$100 Food & Beverage and Proshop Credit.**

#### **Alcohol Policy:**

Per State Law, alcohol purchased off-site may not be brought on-site. All alcohol must be purchased from Flushing Valley. Violators will be asked to leave immediately and suspension of golf privileges is possible. As caring members, please refrain from bringing alcohol onto Flushing Valley premises. In addition, it is unlawful for any homeowner to knowingly provide or sell alcohol to golfers on the golf course property.

#### **Check-In Policy:**

Every member is required to check-in with the Pro Shop prior to play. Play will not be allowed on the course if the Pro Shop and/or facility is not open for business. In the off-season when the course is deemed closed, members will NOT be allowed to walk-on and play without authorization from the management.

#### **Cancellation Policy:**

Members reserving tee-times will be held responsible for canceling the reservation if they cancel at least 24 hours prior to the reservation. Please document the cancellation number for your benefit. Failure to cancel the reservation by phone or in person at least 24 hours in advance, and the Club is unable to resell that tee time, a \$25 cancellation charge per tee slot booked will be charged. Members are provided (2) courtesy no-shows/no cancellations per season (or a maximum of 4 players) before a fee will be charged.

Should weather be a factor in the decision not to play, no penalty will be enforced. However, weather cancellations must be for valid weather causes such as rain, snow, extreme temperatures, etc. After the maximum courtesy occurrence is reached, we will provide Gift Cards for the penalty charged that may be used at the Club. The cancellation policy is in effect during the season of May 15 – September 15 and will not be enforced by fee penalty before and after these dates. Pro Shop staff is unable to provide special privileges.

#### **Membership Term and Course Availability**

The membership term will be from the date of application acceptance with a 2 year commitment.

**Tee Time Reservations:** Annual members will have the ability to reserve tee times two weeks in advance. Reserving tee times for other members but under your name means you assume the responsibility for filling those tee times. If you are not comfortable with assuming this responsibility, please ensure golfer names are provided to the Pro Shop staff when reserving tee times. This also helps us to know who is playing on the golf course at all times.

**Food & Beverage:** Annual members are encouraged to support Food & Beverage services at Flushing Valley Golf Club; however, no minimum spending levels will be enforced. We also encourage annual members to report to us the positives and negatives so we can continue to provide food and beverage selections and quality meeting your expectations. Members can enjoy a 10% off banquet event.

**Billing:** Annual members will be entitled to charge all purchases at Flushing Valley Golf Club (with the exception of tournaments, weddings and similar large events determined at the discretion of management) to their account for monthly billing. Annual members will receive an end-of-month statement summarizing all monthly purchases and payments to the account. Each annual member authorizes Flushing Valley Golf Club to charge the credit card listed in this Application for all charges incurred by the cardholder unless specified within this document. At each month's end, all outstanding items will be charged to the member's pre authorized credit card (unless other methods of payment are stipulated). All balances are due in full by the 30th of the following month. **Amounts not paid by the 30th will be charged to the credit card on file regardless of what payment method was selected. Delinquent accounts will be subject to an interest rate of 2% per month and may result in suspension of account and playing privileges.**

**General:** Annual members must present themselves to the Pro Shop staff in the clubhouse for all account transactions and prior to start of play, and must book their tee time under their name or member number. Annual golf members and their guests must abide by the individual golf club's rules and regulations and respect the rights of all fellow golfers, guests and staff members. Failure to do so may result in the member's privileges being suspended by the General Manager. Suspended members are not entitled to any refund of the membership fee but may appeal their suspensions to management.

**Rates and Initiation Fee:** **There is a \$500 Initiation Fee and \$95 a month for the main membership including cart.**

**Add-ons Members:** Spouses, children under 18 can be added to main membership. A \$30 a month per family add-ons plus \$25 additional per carts a month.

"Membership Revocation Policy:

In the event of non-payment of membership dues, the golf club reserves the right to revoke a member's membership after a period of 90 consecutive days of non-payment.

**1. Membership Payment Obligations:**

- 1.1. All members are required to fulfill their financial obligations by paying their membership fees in a timely manner as outlined in the membership agreement.
- 1.2. Failure to make payment for membership dues within the specified timeframe will result in a notification being sent to the member to remind them of the outstanding balance.
- 1.3. If the outstanding payment remains unpaid for a consecutive period of 90 days from the initial notification, the golf club reserves the right to revoke the member's membership.

**2. Notification and Communication:**

- 2.1. The golf club will make reasonable efforts to communicate with the member regarding any outstanding balance and impending membership revocation.
- 2.2. Notifications will be sent to the member's registered address on file and may also be conveyed through email or other means of communication available to the golf club.
- 2.3. It is the member's responsibility to ensure that their contact information is up to date and accurate.

**3. Membership Revocation Process:**

- 3.1. Following the 90-day period of non-payment, the golf club will send a final notice to the member, clearly stating the intent to revoke their membership if payment is not received within a specified timeframe.
- 3.2. If the outstanding payment is not received by the specified deadline, the golf club will proceed with the revocation of the member's membership.
- 3.3. Upon membership revocation, the member will no longer have access to any benefits, facilities, or privileges associated with their membership.
- 3.4. The golf club reserves the right to take legal action to recover any unpaid membership fees and associated costs incurred during the revocation process.

**4. Reinstatement of Membership:**

- 4.1. If a member's membership is revoked due to non-payment, reinstatement of membership may be considered upon the settlement of the outstanding balance, as well as any additional fees or penalties that may have been incurred.
- 4.2. The decision to reinstate a revoked membership lies solely with the golf club, and the member must adhere to any conditions or requirements set forth by the club.
